Sir,

Please find enclosed herewith the NRLDC fees & Charges bill raised for the Period Oct'l issued by NRLDC vide letter no NRLDC/MO.2038 dated 07.09.11. As per the decision meeting held on 27.04.10, SLDC Delhi is the nodal agency for collected & Disbursement charges based on the CERC Regulation as per clause 22 & 23 of Fees & Charges of RLI related matters notification dated on 28.03.11. SLDC has been settling the accounts from onwards as per the decision taken in the meeting held on 05.04.2011. It was also decided t shall settle the bill for the period Oct-10 to Feb-11 with PGCIL and Discoms. The relevant the minutes of the meeting are as under:

2 Settlement of bills for the period from 01.04.2009 to 31.03.2011

In the meeting held on 01.04.2011 at SLDC, Distribution Licensees were of the view that they ha paid the bills raised by PGCIL including the ULDC part of the RLDC charges upto February 2011 raised by NRLDC for the period October 2010 to February 2011 should be adjusted taking into the of the payment already made for these months to Power Grid for POSOCO portion. To settle the PGCIL representatives were also invited to attend the meeting. The PGCIL representative indica ULDC scheme charges for additional capitalization has already been

issued by CERC vide their order dated 18.03.2011 for the period 2004-05 to 2008-09. The charges for PGCIL portion of the ULDC scheme from 01.04.2009 are yet to be decided by CERC. Once the charges are fixed, PGCIL would raise the bills directly on Distribution Licensees. As such the settlement would take little bit time. Further, since the bills for POSOCO portion for March 2011 shall not be raised by PGCIL, the bills being raised by NRLDC should be paid by Delhi SLDC. The representative of Delhi SLDC and DISCOMs were of the view the new responsibility of collection and disbursement of RLDC charges be transferred to Delhi SLDC only from 01.04.2011 being the beginning of the new financial year for accounting and auditing suitability. Dv.GM (NRLDC) expressed that as now the order for NRLDC fees and charges is already there and POSOCO portion has already been segregated issuing one consolidated bill. POSOCO + Power Grid portions for the month of March 2011 to Discoms of Delhi directly would not be in order. However, PGCIL agreed for reconciliation of bills upto the period of February 2011. Dy. G.M. (NRLDC) intimated that the bills for March 2011 for NRLDC portion have already been raised. It was also consented to take into account of Bawana CCGT and RPH generation allocated to outside state and would be adjusted in subsequent bills.

However, in the 20th Commercial Committee of NRPC held on 24.08.2010 NRLDC indicated that from October 2010 to February 2011 the bills are also required to be settled by SLDC. It was indicated that the credit has already been given by PGCIL for the PowerGrid portion of ULDC charges to the distribution licensees for the above said period. NRPC advised NRLDC to provide the documents in this regard to SLDC so that the same can be settled. NRLDC has given the documents of the settlement by Power Grid through the bill dated 04.05.2011 through its letter dated 05.09.2011. The same has been intimated to SLDC through its letter dated 07.09.2011 by RLDC. As such SLDC has taken the bill date as 07.09.2011 instead of the claim of NRLDC that the bill date is 23.03.2011 (the original date of raising of the bill to SLDC).

The apportionment of RLDC charges portions to Delhi has been done based on decision taken in the meeting held on 05.04.11 in the chamber of Dir(Oprn), DTL.As decided in the meeting held on 05.04.11 the payment to be made before 2 days of due date of bill issued by NRLDC other wise surcharge would be applicable as per regulation.
